GENERAL INFORMATION

Please make all cheques or money orders payable to the Rottweiler Club of Canada. A listing fee of \$8.40 must accompany payment if the dog entered does not have an individually registered C.K.C. number or an E.R.N. number.

U.S. entrants may pay fees by money order made payable in Canadian funds or personal cheque in U.S. funds for the full amount of the fee(s) (there will be no exchange rate). Personally discounted cheques will not be accepted. Please **DO NOT** mark cheques "Payable in Canadian Funds" or "at par" as these are not readily cleared by the banks. Tendering an NSF or post-dated cheque will be considered as non-payment of fee(s) and will subject the maker of the cheque to a \$25.00 "handling fee" and disciplinary action. (C.K.C.) **NO REFUNDS ON OVERPAYMENTS OR DUPLICATE ENTRIES.**

EVENT REGISTRATION NUMBERS: For the sole purpose of entering C.K.C. Events to acquire C.K.C. degrees and titles, individual registration will no longer be required for foreign born, foreign owned dogs. Instead they may apply for an **EVENT REGISTRATION NUMBER (ERN)**. (This ERN number replaces a C.K.C. We shall be accepting entries with only **one** entry per envelope. **NO EXCEPTIONS!** Positions will be assigned on a first come first served basis. Once the advertised limit has been reached, all remaining entries will be assigned a position on the "Alternate List" in the order they are received. Entrants will be notified that their entry has been received and accepted for the primary test or alternatively the position number as an alternate, by mail, phone or email which ever is appropriate.

All entries must be complete, signed and must be submitted on the current official CKC entry form (back side of form not required). Entry submitted in any other size or format will be rejected. Telephone entries will not be accepted by the Show Secretary. Incomplete or conditional entries received without fees, or entries received by the Show Secretary after the advertised closing time (regardless of when or how they were sent) will not be accepted. Please print or type all entries legibly in block letters. The Show Secretary will not accept responsibility for errors that are a result of our inability to interpret your entry form. Please type or use black pen and avoid using small cramped lettering.

MEETING PLACE AND DRAW

Rendezvous is scheduled for **7:30 a.m. Tuesday July 14 2009** at Blue Ribbon Kennels (<http://www.blueribbonkennels.ca/>) Bragg Creek, AB (easily accessed by Highways 22, 8, or the Trans Canada). Blue Ribbon is located close to the hamlet of Bragg Creek. It is a mere 7.5 kms south of the junction of Highways 22 and 762. This is where the draw for tracks will take place. Any primary entrant(s) who is absent at this time will forfeit their position to the first Alternate present.

BITCHES IN SEASON may compete, however, they will run last. Please advise the Test Superintendent upon arrival.

The owner of a dog entered in this show is entirely responsible for any error in the entering of his dog, regardless of how, or by whom the entry was made.

REFUNDS: Entry fees for dogs **NOT** entered in the test will be refunded within 10 days after the day of the test. When a dog is withdrawn after the closing date, refunds will **only** be permitted when the vacancy is filled by an "Alternate".

Rule13.7: It shall be the duty and obligation of the test-giving club to see that a judge, club official volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Tracking Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

AWARDS AND LUNCHEON

At the conclusion of the Tracking Test the Judge will present rosettes to all the successful teams and the Club will award prizes to the successful teams. Every entrant exhibited will receive a token gift. At the end of this event you are invited to join your fellow competitors for lunch which will be held at a restaurant in Bragg Creek at your own expense.
